Guidance Notes

- Entrants are required to enter the site according to the route on the final Instructions.
- Arrival is between 9.30am and 10.30am.
- Entrants are asked to remain on site until 4.00pm unless by prior arrangement or an emergency arises.
- On arrival entrants must follow the guidance of marshals who are identified by high visibility jackets, and be guided to the appropriate parking place.
- Drivers must observe the 5mph speed restriction at all times and be aware of other vehicles and particularly pedestrians as the site is a public park with no fencing to prevent access from any direction for pedestrians.
- Drivers must only move their vehicles under the supervision of the marshals, whether entering or leaving the site . Should the need arise to move a vehicle, marshals should be informed to ensure safe passage through the site.
- There is no restriction on picnicking but barbecues and any form of fire are strictly forbidden.
- Entrants plaques can be obtained from the organisers tent any time after arrival.
